# **Organizational Update**

- ABNS website is continually refined and updated. A Public Member Bureau was added to the
  Members Only section. Members have been asked to contribute names/contact information to
  add to the site, of potential public members they would recommend, but response has been
  poor. Individual members are asked to look around them for people they know who would be
  great Public Members, such as individuals in their place of worships, schools, friends, etc. Each

- During Nurses Week, May, 2011, Sandra Lee Schafer, ABNS Member at Large, presented the 2011 ABNS Award for Nursing Certification Advocacy to East Jefferson General Hospital (EJGH), Critical Care Division in Metairie, LA. Information about the award recipient and the three honorable mention recipients are found on the ABNS website under the Awards tab.
- Betty Provolt, ABNS Public member attended the Citizen Advocacy Center's Annual Meeting on October 20-21, 2011. The topic was Achieving Regulatory Excellence and Effective Discipline Programs.
- Twenty-one health care organizations submitted nominations for the 2012 ABNS Award for Nursing Certification Advocacy by the January 29, 2012 deadline. The award recipient and those receiving honorable mentions will be announced at the March 2012 ABNS Assembly meeting.
- Maria Shirey, ABNS President-Elect, published an article in JONA that referenced the ABNS Research Summit Process.
- ABNS established a website link to NursingLicenseMap.com, at their invitation. Jackie Stewart was invited to post a blog on the site that highlighted the value of nursing certification.
- Wade Delk (AMP) presented a legislative update at the Fall 2011 Assembly meeting.
- Joan Stanley (AACN Colleges of Nursing) presented an update on LACE at the Fall 2011
   Assembly meeting.
- Melissa Biel (ABNS Deputy Director) and Bonnie Niebuhr (ABNS CEO) have been asked to
  present with James Stobinski (CCI) on the importance of accreditation as well as the value of
  certification at the AORN Congress in March, 2012.

# **Organizational Update**

- ABNS hosted the annual Spring Assembly meeting and Certification University in March 2011 and the Fall meeting in September, 2011.
  - Program evaluation was distributed to members. Over 93% of participants indicated a "high" level of approval for the ABNS meeting and Certification University. Areas for improvement were reviewed and suggestions for future meetings used for planning.
  - o PR Committee members continue to provide mentors for first time Assembly attendees.
  - o Honored and recognized special accomplishments in the field of nursing certification.
- In conjunction with the Program Committee, planned and implemented the Certification Assembly meeting for Fall 2011. Booked speakers, applied for CNE approval through AACN, and received approval for 5.50 contact hours.
- ABNS Accounting Firm, Ciuni and Panichi, completed a review of June 30, 2011 and 2010 ABNS financial statements.
- Quarterly ABNS/ABSNC newsletter is distributed electronically to membership.
- A Marketing Tool Kit was launched in May, 2011. Subsequent additions to the toolkit will be posted o the Members Only section of the website.
- The Call for Nominations for a Secretary/Treasurer, and Nominations and Election Committee members was disseminated in Fall, 2011 and nominations were received. The Slate of Nominees was disseminated to the Regular Members in January, 2012. Elections will occur on March 2, 2012 during the ABNS Assembly's business meeting.
- The ABNS Board and Staff met with Affiliate members at the Fall 2011 Assembly meeting to
  discuss their views on how ABNS can increase revenue. Further discussion about ideas that
  were generated will occur at the ABNS Spring 2012 Assembly meeting and post Assembly
  meeting Board Strategic Planning Retreat.
- Poll questions posted by members on Groupsite are not generating significant responses.
   Members are encouraged to respond to questions so that information on a specific topic is communicated widely to be of benefit to members.
- Member Organizational Profile survey completed in May/June 2011 and posted on the ABNS website under Members Only section. The 2012 survey will be distributed to members in May.

#### **Success Marker III**

ABNS advances knowledge regarding specialty nursing certification through research.

 Encourage and facilitate the conduct and dissemination of research on certification and patient outcomes, continued competence, employer support of certification, and the impact of certification in the workplace.

## **Organizational Update**

- With support from the Canadian Nurses Association, the certification bibliography was updated to include all 2011 certification-related documents is in process. The updated bib is available on the ABNS website.
- The Research Committee created a document that outlines the various models that ABNS may use to support and facilitate research. This was disseminated to members.

- The Research Committee has developed a process to allow for sharing of research projects. It was disseminated via the quarterly newsletter and Groupsite. Additional focus needs to be placed on this tool to be more actively used.
- In partnership with AACN Certification Corporation, 26 ABNS members are sponsoring a national research project to examine trends in specialty certification of RNs in acute care hospitals using the National Database of Nursing Quality Indicators® (NDNQI®). Dr. Diane Boyle, NDNQI Principal Investigator, is leading the two Phase research project, which began in November 2010. Phase I is complete and Phase II is underway. All participating organizations have received their credential-specific data from Phase I.

## **Success Marker IV**

ABNS supports continued competence as a means for ensuring patient safety.

## **Organizational Update**

- The ABNS Board of Directors endorsed the statement on Continuing Competence as proposed by NBCHPN. ABNS is implementing a marketing and outreach plan, funded by NBCHPN, to increase use of the statement.
- As part of the work of the NBCHPN sponsored Continuing Competence Task Force, the Research Committee discussed strategies to identify how nursing certification organizations are using continuing competence in certification and recertification programs.
- BCEN has completed a review of state boards that reference nursing certification in state
  practice acts. This summary document has been shared with ABNS and is posted on the ABNS
  Members only website.
- Continuing competence statement manuscript (Case DiLeonardi & Biel) was accepted for publication in the Journal of Nursing Education in Nursing.
- Jackie Stewart, ABNS President and Betty Case DiLeonardi (NBCHPN) presented a poster session on the Continuing Competence document at the 2011 ICE meeting.

ABNS promotes accreditation and recognition of quality specialty nursing certification programs.
